



## LIETUVOS PREKYBA SU SAUDO ARABIJA

Prekių apyvarta tarp Lietuvos ir Saudo Arabijos 2013 m. sudarė beveik 530 mln. Lt, o Saudo Arabija buvo 23 didžiausia eksporto rinka Lietuvos įmonėms. 2008-2013 m. laikotarpiu prekių apyvarta tarp šalių išaugo daugiau kaip 6 kartus. Eksportas 2013 m. sudarė 512 mln. Lt ir buvo 67,3 proc. didesnis nei 2012 m. Nors tokį augimą daugiausia lemia javų eksportas, kuris 2013 m. sudarė net 85,8 proc. viso eksporto, tačiau auga ir kitų pramonės šakų eksportas: 2008-2013 m. laikotarpiu lietuviškų baldų eksportas išaugo 3,4 karto, paskutinius keletą metų ženkliai augo drabužių eksportas ir 2013 m. sudarė virš 30 mln. Lt. Iš kitų pramonės šakų santykinai gerus eksporto rezultatus demonstruoja medienos, maisto bei metalo apdirbimo pramonės.
